


Community Financials Software Update

The transition to the new software will require each homeowner to establish a new portal. All autopay and bill pay will need to be reset. The address to which we mail payment will change. The transition is expected to be August 1st, 2025.

CSA45

The County Service Area No. 45 Public Works Advisory Committee (Oak Hills) serves as a bridge between the community and the County's Board of Supervisors, offering advice on various issues related to CSA No. 45. These include public utilities, sanitation planning, fire protection, transportation, and highway traffic.

Here's a quick breakdown of its structure:

- Appointments: Five members are appointed by the Board of Supervisors—two from Oak Hills Subdivision east of Cathedral Oaks Drive, two from the west side, and one at-large residing in CSA45.
- Term Length: Each member serves a three-year term until a successor is appointed.
- Meetings: At least two meetings per year, held at a regular time and place, and open to the public.

Following the mowing, CalFire will begin weed whacking branches and clearing the ground starting on June 2nd. This work is also anticipated to last for one to two weeks.



One Key Card for ALL Recreational Access

Pool Hours

Pool 6am - 8pm Spa 6am - Midnight

Our vendor, Core Surveillance, is in the final phase of the project to enhance security at the park, pool and tennis courts with an implementation date of June 1st, 2025.

Please note that access to all three areas (pool, park, and tennis courts) will require a single key card. If you already possess a key card for the pool, no action is needed, as your current card will grant you access to all facilities.

If you require a key card, please reach out to the office.

Following a vote by the Board of Directors, **each household is now allotted one key card for facility access**. If your household currently has more than one key card, please contact our office to arrange for the return of the additional card(s).

To ensure the security of our pool area, please do not hold the gate open or open the gate for anyone. Homeowners have key cards for access, and we ask that you allow them to use their cards. Our office number is posted on the bulletin board outside the gate. Please refer anyone seeking access to our office for assistance. Please be aware that if you allow someone into the pool area who then causes damage to the grounds & rec center, you may be held responsible for their actions.

Please remember that access to all recreational facilities will require a key card and is exclusively for Oak Hills Homeowner Association residents, and their guests (with a limit of five guests per household).
