LOCAL BIKE/PEDESTRIAN TRAIL NEWS

You've probably noticed the construction project underway where HWY 156 goes over the railroad tracks east of Castroville. Work began in January to build a safe route for students from Castroville so that they may bike and walk to North Monterey County High School and Elkhorn Elementary School. The project includes the construction of a bike and pedestrian bridge over the tracks and a new multi-use path that will run parallel to HWY 156 from the bridge to downtown Castroville at Merritt Street. Completion is expected by the end of 2017.

In addition, a 1.17 mile multi-use trail is in the planning stages for the Moss Landing area that will connect Moss Landing Road, south of the harbor, to Jetty Road, at the north end of the harbor. Pedestrians and bicyclists must currently use a narrow, uncomfortable shoulder that runs along HWY 1, a spot that always sees excessive traffic. The trail will offer a much needed safer alternative.
