News from TAMC

Stay informed! Here's the latest news from TAMC (Transportation Agency of Monterey County)

Highway 156 West Corridor Widening Project:

- A Traffic and Revenue Study is in progress that is being paid for by TAMC and Caltrans to determine if a toll road will be a viable choice to fund the project. What will people be willing to pay as a toll? Who will be tolled visitors and/or locals? Anticipated traffic volume? How long to pay off the construction? The Study should be completed in February, 2013 and another round of community meetings will be scheduled.
- An EIR (Environmental Impact Report) is being conducted by Caltrans to evaluate potential noise, traffic reduction impact, protection of animal species, etc. and should be completed in early 2013.
- By completing the 156 West Corridor Widening Project, emergency responders will have better and faster access and the current Highway 156 will become a frontage road, increasing traffic safety for locals. The challenge is how to fund the project in today's environment so a toll road is being evaluated to avoid tax increases.
- Scheduled for completion in 2015, the Prunedale Improvement Project includes construction in a high accident corridor of three new interchanges / overpasses along US 101 through North Monterey County at: Russell/Espinosa, Blackie/Reese, and Crazy Horse Canyon/Echo Valley Roads. The project will also close the remaining gaps in the concrete median barrier from Crazy Horse Canyon to Russell/Espinosa, resulting in one continuous barrier. Additional Improvements will also be made to the San Miguel flyover and to local roads throughout the corridor to improve access and local circulation. The San Juan Interchange has started construction to increase safety in the area of the Red Barn. Scheduled to open in January is the new Prunedale South Road overcrossing, near Blackie Road.
